



January 01, 2021 WEEKLY Update Regarding COVID-19

Dear Residents and Families,

The COVID-19 Vaccine is coming to Lakeview on January 13th, 14th, and 15th. We will be working through the LTC Pharmacy Partnership for the COVID-19 vaccination. Please know that there will be set times on January 13th, 14th, and 15th and we will communicate those exact times once we know them. For now, you need to make sure you have filled out the Consent Forms that were delivered to your doorstep, Thursday, December, 31st. Those forms along with a copy of the front and back of your Medicare and other insurance cards will need to be turned in to the Command Center in Heritage or the screening stations at NorthPointe or Southridge immediately.

As a five-star retirement community, our top priority has always been the health and safety of our residents, families, visitors and staff. Lakeview is following guidance from multiple governmental agencies including the United States Centers for Disease Control (CDC), the United States Centers for Medicare and Medicaid Services (CMS), the Kansas Department of Health and Environment (KDHE), the Kansas Department of Aging and Disability Services (KDADS) and the Johnson County Department of Health and Environment (JCDHE).

Over the last week in Independent Living (IL), one of the two residents who tested positive last week passed away. Our heartfelt thoughts and prayers go out to their family and loved ones in this time of loss. **If you are feeling sick or have been recently notified of an exposure to COVID-19, please reach out to Steffany Brosa at (913) 744-2451.** She can help make arrangements for Lakeview staff to come and collect a COVID-19 testing sample. We usually get these test results back within 24 hours.

In the licensed areas, we did have 1 new resident case in Eastside Terrace earlier this week. During the current outbreak, we have had 68 licensed area residents test positive for COVID-19 broken out as follows: 29 1st Floor Care Center, 34 2nd Floor Care Center, 2 ET Rehab, and 3 Assisted Living. Currently, 4 of these residents are being treated in our COVID unit on the 3rd floor of Eastside Terrace, **no** residents are hospitalized, **46** residents have recovered and unfortunately **18** have passed away. Our sympathies and prayers go out to the families and friends of all of those we have lost. The last positive resident case in each licensed area is as follows: 1st floor of the Care Center November 3rd, 2nd floor of the Care Center December 12th, Eastside Terrace 2nd Floor Rehab



December 27th, and Assisted Living December 6th. We will continue to test Assisted Living, Care Center and ET 2nd floor residents every couple of days and our licensed area staff twice a week. Finding the positive cases quickly gives us the best fighting chance to minimize the spread of COVID-19.

On the employee front, Lakeview has conducted 565 tests in the past week, yielding 3 positive COVID-19 result in employees. During the current outbreak that started back on September 27th, we have had 67 staff test positive for COVID-19. Currently we have a total of 5 staff off due to positive test results.

Lakeview's Independent Living reopening plan will continue at a slow and cautious pace. **IL Open:**

- Outpatient Therapy by appointment only with aquatic therapy available.
- Indoor & outdoor walking provided you wear a mask and maintain 6' feet of social distancing. Please use the sidewalks and walking trails while walking around the beautiful Lakeview campus.
- The Art Studio in Northpointe & Woodshop in Heritage are open following social distancing guidelines.
- All high rise common area spaces are open to residents only (no visitors) with 4 unrelated residents allowed per table and residents must wear masks the whole time. Please sign the log book in these common area spaces in the event of a COVID-19 exposure and we need to contact trace.
- Eastside Terrace (744-2306) & Heritage (744-2497) Beauty Shops are open by appointment only.
- IL residents can have visitors in their apartments, on their balconies/patios, and outside provided the resident and visitors wear masks, practice social distancing of at least 6 feet, and limit to less than 5 people. We recommend all visitors be screened at one of the screening areas to help protect everyone's safety. Visitors may not stay overnight unless providing medical assistance.
- Library hours are Mon – Fri, 9:00 - 11:00 & 1:00 - 3:00. No sitting or reading in the library at this time.
- Country Club Bank is open Mon 9:00am-noon, Wed 1:00-4:00pm, Fri 9:00am-noon.
- ET Fitness Center hours are Mon – Fri, 8:00 - 3:30pm. Living Well staff will be monitoring the room.
- ET Aquatic Center is open Mon – Fri, 8:00 - 3:00pm and you must call 951-3812 to get an appointment time. The locker rooms are closed, however, the restrooms remain open.
- "On-campus taxi service" (in lieu of regular shuttle service) will be by appointment **only** Mon – Fri, 8:00 – 3:45. You will need to call 744-2490 to schedule a pick-up and return time.
- What-Not-Shop contactless sales are open to residents and staff. Items may be purchased by dropping money in the after hour's sale box outside the What-Not-Shop and taking the item with you.
- Pantry "shop at home" ordering continues by calling 951-3831 with your grocery list. Orders placed by noon on Monday will be delivered Wednesday and orders placed by noon on Wednesday will be delivered Friday. Deliveries are made to your doorstep and charges are billed to your resident statement.
- IL laundry flat linen service resumed Monday, November 30th following the normal weekly schedule.
- Meals continue to be delivered to your doorstep.

Health and Safety Precautions:

- **W**atch your distance by maintaining 6' between yourself and others.
- **W**ear a mask anytime you are outside your residence (Kansas & Johnson County requirement).
- **W**ash your hands for 20 seconds with soap and water or use hand sanitizer.
- Avoid large gatherings and indoor entertainment venues.

2020 has been quite a year. We are hoping for better times in 2021. Someday soon, hopefully we can all get to together to reflect on the year we've had. For now, let's continue onward and upward while maintaining our safe "bubbles".
